Life sciences study design

Sample size	No sample size calculation was required for this study. Samples were collected in the wheat field according to the disease incidence, and each sample represents a single infection spot in a single field. As stripe rust pathogen is biotrophic, it is very difficult to collect and multiply samples in a huge quantity.
Data exclusions	To obtain high-quality data, inferior raw reads sequenced in the study were excluded. We also excluded variant data using different criteria, including missing allele, minor allele frequency and others, to filter the genotypic data. For the trajectory analysis, meteorological data were selected based on the wheat planting pattern and features of stripe rust disease occurrence.
Replication	Replication was not available in the study. The findings are reproducible with the codes provided.
Randomization	Sampling of wheat stripe rust pathogen were conducted randomly in the main wheat-growing areas, which was described in the method part.
Blinding	As we are familiar with the features of the disease we studied, like airborne and polycyclic, blind data collection is not available in this study.
