Sample size	To build the predictive model, the 327,302 sequences were collected from CAZy and NCBI, and finally divided into 119 families.
Data exclusions	Data were not excluded from analysis.
Replication	All experiments for determining the enzyme activity were performed at least three replications.
Randomization	For evaluation of the performance of the predictive models, the strategy of 10-folds validation was used. The samples were randomly split into the train or validation dataset.
Blinding	In the 119 protein families, one protein in each family was selected as the blinding or independent test dataset, which not included for train and validation the performance of the models.
