Data collection

Genome were sequenced using leaf DNA with HiFi PacBio technology, Chromosome conformation capture (Hi-C) library was captured and sequenced on the Illumina platform. Curated Oryza repeat database was downloaded from <http://rice.uga.edu/index.shtml>. Strand-specific RNA libraries were constructed and sequenced using the Illumina PE150 platform (Berry Genomics; Beijing, China) (<https://www.berrygenomics.com>).

Data analysis

HiFi reads were assembled using hifiasm (0.16.1-r375) along with Hi-C reads.
 Hi-C reads were mapped to the haplotigs by Bwa.
 Hi-C interaction maps were inspected by Juicebox.
 Syntenic relationships of the *Oryza longistaminata* scaffolds with *O. sativa* chromosomes were checked by whole genome alignment using MUMmer4 and visualized by SyRI.
 Repeat sequences were analyzed and annotated using RepeatMasker.
 Protein-domain annotation was performed by InterProScan.
 The syntenic analyses were performed and plotted by MCScan via jvarkit.
 GENESH was used to verify the genes in S-locus syntenic analyses.
 Raw reads of RNA-seq were filtered by fastp v0.23.0 with default parameters, clean reads were aligned to the genome using HISAT2. v2.2.1 and FeatureCounts v2.0.1 was used to count the reads numbers.
 PyMol (<https://pymol.org/2/>) was used to visualize the structures.
 iTOL (<https://itol.embl.de/>) was used for visualization, annotation, and management of the trees.
 Sequence alignments were performed using MAFFT version 7.407.
 Species-level phylogenetic trees were constructed by phylomatic or Timetree (<http://www.timetree.org/>) and gene trees IQ-TREE.
