Study description

We compile the most comprehensive global live (terrestrial) vertebrate trade database (GLVTD) available to date. The GLVTD catalogues most species in four vertebrate groups – mammals, birds, reptiles and amphibians – that are involved in the live wildlife trade (including illegal trade), or kept in zoos, or sold by online trade and physical stores (OTAPS) for pets or other uses, and the countries that imported or exported this wildlife. We use this database (i) to demonstrate the geographical distribution of colonization pressure for alien vertebrates in trade across countries and taxa; (ii) to identify hotspots of establishment richness for alien species, and the contributions of colonization pressure, socio-economic factors and climate conditions to establishment richness; (iii) to quantify flows of alien species and established alien species between native regions and received regions.
