Sample size

79 clinical *P. aeruginosa* strains from four European countries, varying antibiotic resistance profiles, and different genomic clusters were included. Additionally, PAO1, as a laboratory standard strain was used. This provided us with a broad bacterial collection.

Based on the inclusion criteria (see "Methods") four ancestral bacteriophages were selected for the in-vitro evolution assay. For further testing, evolved bacteriophages were selected based on descent, as well as a distinct efficiency and host range in preliminary tests.

Data exclusions

No data was excluded from the analysis.

Replication

The reproducibility of our findings was successfully confirmed by conducting the experiments in replicates (biological and/or technical). The in vitro evolution assay encompassing four bacteriophages and eight bacterial strains in parallel was only performed once as proof of concept to demonstrate the feasibility of our approach.
