No sample-size calculation was performed, but the determination of the number of animals needed was based on past wide-field calcium imaging studies using similar imaging and analytic techniques.

Data exclusions

One mouse (mouse #4) only rarely walked spontaneously (6% of the number of walk periods as the next-lowest walking mouse) and was not included in the spontaneous locomotion analysis. Exclusion criteria were not pre-established.

Replication

The experiments were performed in 7 animals across a large number of trials (~1500 total instances per behavior period across animals).

Randomization

The order of motorized treadmill periods and parameters were randomized at the start of each trial.

Blinding

Blinding was not performed during data collection or analysis. Blinding was not necessary as all analyzed measurements were performed with automated processes applied the same to all data.
