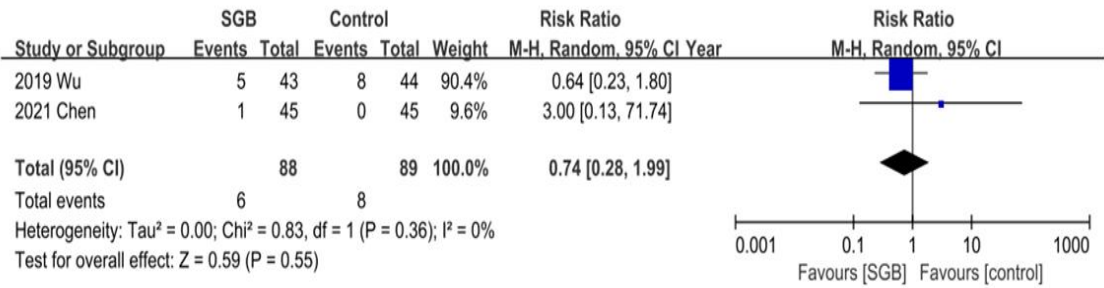


Figure S1 Forest plot for PONV within 24h after surgery.

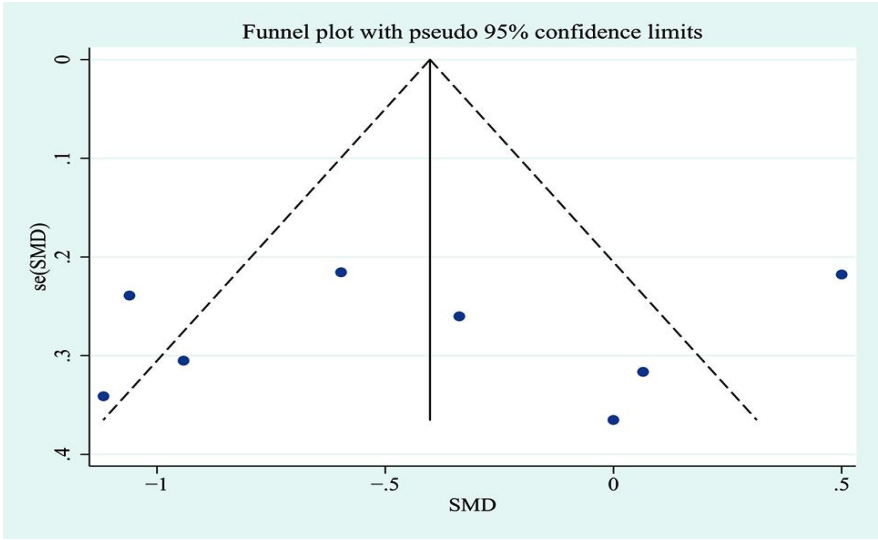


Figure S2. Funnel plot evaluating publication bias

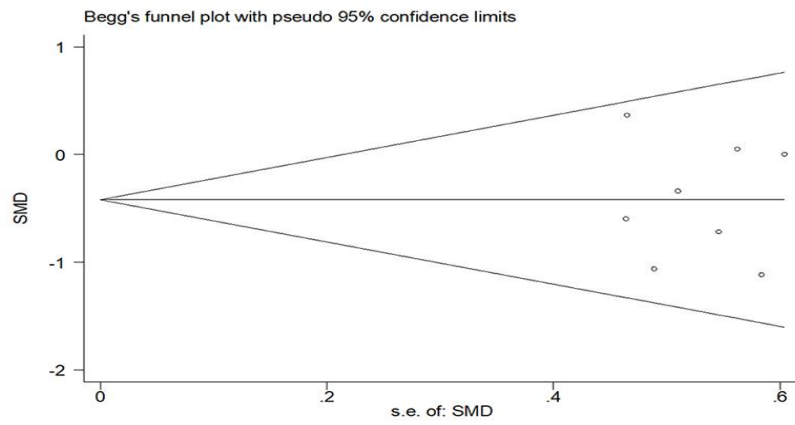


Figure S3. Begg's test for evaluating publication bias.
