Data from 1 mouse was excluded from the cocaine-paired chamber latency analysis (Fig 4C) as a statistical outlier.

Replication

The experimental findings were successfully reproduced in 3 cohorts of mice over 3 years.

Randomization

Mice were matched for HIV infection or sham-infection based on engraftment data and sex, in order to have representation among all groups. For conditioned place preference tests, mice were matched for cocaine or saline-only based on initial preference data in order to prevent initial biases from impacting results.

Blinding
