Replication Each experimental condition was replicated in biological triplicates in every given experiment, and sufficient agreement was found across all data points in each experimental condition

Randomization Colonies were selected randomly from agar plates when being prepared for experimental pre-cultures, a single colony represents one biological replicate. To measure the performance of strains, three single colonies of target strain were randomly picked up as biological replicates. The sample allocation was not available because patient or human population data was not involved in this study.

Blinding Microbial strains were used in this study. Unlike the clinical trials, blind is generally not necessary for the microbial fermentation experiments, in which a microorganism is the object of study.
