Sample size	Sample size for each drug was determined by including all isolates for which high quality phenotypes and whole-genome sequences were available.
Data exclusions	Isolates were excluded from analysis if they had a mixed allele call at a previously identified genomic loci associated with resistance or if the phenotype was poor quality (further described in Methods).
Replication	This study provided a descriptive analysis of a large-scale quantitative resistance dataset. The lack of other published large datasets with quantitative resistance data for tuberculosis limits replication of this study currently.
Randomization	Randomization is not relevant to this study. Mixed effect models including a variable for site of collection were used to control for phylogenetic and technical variability.
Blinding	Blinding was not possible for this study as the purpose of the analysis was to link individual genomic mutations with a resistance phenotype.
