Data collection	A command line interface in python 3.8 was used to collect data of magnetic bead position using ximea camera (xiQ USB 3.0 SuperSpeed). All codes were custom written and provided in the github link- https://github.com/Ojas-Singh/oOo
Data analysis	Recorded force curves were analyzed in Auto-stepfinder named MATLAB programme (version MATLAB2021a, MATLAB2022a) for lifetime and step-height measurements. Exponential decay fitting of the survival plots was performed using Origin 2018. Others were plotted using Origin 2018 or python 3.8.

Sample size	Sample-size calculation was not performed, however, the sizes were sufficiently large to reduce the errors in the estimation of the lifetimes from the survival plots from force-spectroscopy studies.
Data exclusions	We have excluded the force-curves from the analysis for which the lifetimes are too small, i.e. less than 0.1 sec, based on the temporal resolution of our Magnetic tweezers instrument (lifetime of mechanical clamping using voice-coil, not data acquisition rate).
Replication	All the reported experiments and simulations were repeated in triplicates except experiment to determine molecular fatigue and rates. For fatigue we needed to study from single molecule. We have combined all the kinetics data which were collected from different replicate batches (more than three) in one graph for better fitting as well as to increase the sample size. For every independent experiment, a new set of modified magnetic beads, modified cover-slips and protein batch was used.
Randomization	No randomization was needed.
Blinding	Blinding was not required as we have considered all the data for analysis. The analyses were done using already standardized protocols and common softwares.
