Study description

Our study is a randomized controlled trial of an AI decision aid for live tutoring interactions. Our study includes both quantitative and qualitative findings.

Research sample

Our study involved 900 tutors and 1,800 K12 students that have been identified as needing tutoring. These students comes from a Title I school district.

Sampling strategy

We randomized treatment and control on the tutor-level. About half of our tutors had access to our AI system, and the other half tutored as normal without the AI system.

Data collection

Tutoring takes place virtually. Thus, we collected interaction data from the tutoring provider. We collected session-level data and tutor characteristics from the tutoring provider. We collected student characteristics from the school district.

Timing

end of March - end of May 2024 (2 months)

We will exclude students who were initially on the tutoring roster, but never actually received tutoring services.
We exclude tutoring sessions with tutors who are inactive or become inactive during the study. We also exclude tutoring sessions with non full-time tutors from the study.

Randomization

We performed a simple randomization of tutors participating in this study to one of two conditions:

- (1) Treatment group: Tutors get access to an expert-guided LLM assistant in their tutoring sessions.
- (2) Control group: Tutors do not have access, and tutor as normal in their tutoring sessions.
