Introduction

Thank you for considering completing the Mapping the UK AHP Practitioner-Academic / Clinical-Academic Workforce Survey 2025. This survey has been developed as part of the Community for Allied Health Professions Research (CAHPR) Accelerator Project 2024 (CAP24). The survey is being hosted by Royal College of Occupational Therapists (RCOT) on behalf of CAHPR.

Completion of this survey is anonymous, and the results will not be linked back to you in any way. The survey will take approximately 10 - 15 minutes to complete. You can save progress and complete the survey in multiple sessions. You are free to withdraw from completing the survey any time before you submit your responses. Only submitted responses will be analysed.

Through this survey we aim to generate accurate intelligence of the AHP Practitioner-Academic (Clinical-Academic) workforce across the UK.

We aim to collect data for; i) AHPs with formal practitioner-academic / clinical-academic appointments, and ii) AHPs with dedicated research time as part of their role. Therefore, the survey is open to responses from UK registered AHP practitioners who have dedicated research time as part, or all, of their current role.

We have chosen to use the term 'practitioner-academic' throughout this survey (with the above description clearly defining who the target population is). This is because the term 'practitioner-academic' inclusively captures the breath of our AHP workforce and the settings AHPs work in, whether or not they have the title clinical academic. As the term 'clinical-academic' is widely recognised, it is used in the survey title and introduction for context.

What is dedicated research time?

The term dedicated research time is used throughout this survey. This relates to all research activities, including but not limited to: Undertaking a research fellowship award, undertaking or leading research, supporting the delivery of research, research capacity building, developing research leadership in others, research mentoring and supervising research students. **Please note for the purposes of this survey, we are not including the following as research activities: Audits, quality improvement projects, service development and evaluation projects (unless under research protocol).**

Diversity data

There are a number of questions at the end of this survey to collect diversity data. Completion of this section is optional. We collect diversity data because it helps to identify and remove barriers to inclusion, for example, by exploring areas of under-representation of specific groups of people.
