Representing the health facility that you work for, you will be asked about the post-abortion care services offered in your facility and about the facility’s capacity to offer these and other related services. You will also be asked for your opinion about provision of these services. Your participation is voluntary, and you will not receive any compensation, monetary or other, for participating in this study. Risks There are some potential risks to participating in this study. One risk is that some of the questions may make you uncomfortable. You may skip these questions or any others that you are unwilling or unable to answer. You may also stop the interview at any time.
