## What does my participation involve?

### 1 Introduction

You are invited to take part in this research project, titled “Assessing vulnerabilities and community-based adaptation strategies for communities in Southwest coastal Bangladesh”. You have been invited because of your direct experience with climate extremes in this area. Your contact details were obtained from the Non-Governmental Organisation (NGO), Jagrata Juba Shangha, who have a long track record working on disaster risk management and climate change in urban and peri-urban Khulna.

This Participant Information and Consent Form explains the research taking place and describes the processes for you to take part. Knowing what is involved will help you decide if you want to take part in the research. Please read this information carefully. Ask questions about anything that you don’t understand or want to know more about. Before deciding whether to take part, you might want to talk about it with a relative or friend.

Participation in this research is voluntary. If you don’t wish to take part, you don’t have to.

If you decide you want to take part in the research project, you will be asked to sign the consent section. By signing it you are telling us that you:

- Understand what you have read
- Consent to take part in the research project

You will be given a copy of this Participant Information and Consent Form to keep.

### 2 What is the purpose of this research?

Climate change is the most pressing global challenge of our time, causing significant threats to the well-being and livelihood of communities around the world. Due to its geographic location, socio-economic characteristics, low-lying structure and proximity to major river systems and the Bay of Bengal, south-west coastal Bangladesh stands out as a region highly susceptible to the impacts of climate change. Since Khulna City Corporation is situated at the confluence of the Rupsha and Bhairab rivers, it faces acute climate-driven hazards including cyclones, urban flooding, land subsidence, and saltwater intrusion. Studies have shown that the burden of those hazards is particularly experienced by vulnerable groups including female-headed households, ethnic minorities -specifically indigenous groups like the Munda and Dalits, landless, farmers and fisherfolk, low-income households, climate migrants, and persons with disability. The proposed

research aims to focus on integrating the principles of wet cities and climate justice to assess vulnerabilities while proposing adaptation strategies that uphold the principles of fairness and inclusivity for vulnerable groups. By adopting a climate justice lens, this doctoral study will pay attention to the differential impacts of climate change on those groups. It seeks to understand the social dimensions of vulnerability, the underlying drivers of inequality, and the specific adaptation needs and priorities of those groups. Moreover, the research aims to inform evidence-based decision-making, policy formulation, and implementation processes, leading to the development of more equitable and sustainable adaptation strategies in the region.

The results of this research will be used by the researcher Md. Riad Hossain to obtain a PhD degree in Environmental Engineering. This research has been funded by RMIT internal HDR funding.

### **3 What does participation in this research involve?**

If you agree to participate in this research project, you will be invited to attend an interview expected to last between 35 and 45 minutes. Your interview will be held in person at any suitable place of your choosing and will be arranged during working hour. During the interview you will be asked for your opinion and views regarding livelihood impacts of climate extremes, your coping strategies, adaptation measures, and barriers to accessing innovative technologies. The questions will be asked in English and / or Bengali and you may reply in either English or Bengali. The interview will be audio recorded so that a transcription can be created and sent to you. There are no costs associated with participating in this research project, nor will you be paid.

To participate in the interview you will need to sign and return via email the attached consent form to Md. Riad Hossain ([S4062475@student.rmit.edu.au](mailto:S4062475@student.rmit.edu.au)) and Nick Brown ([nick.brown@rmit.edu.au](mailto:nick.brown@rmit.edu.au)).

After the interview you will be sent a copy of the transcript of the interview and you will have the opportunity to edit or clarify any of your statements. If you do not suggest any edits or clarifications within 14 days, the research team will take the transcript as accurate.

You may withdraw your consent up until the point the research has been submitted for publication.

### **4 Other relevant information about the research project**

Six (06) participants groups will be included in this research project including women and female-headed households, ethnic minorities—specifically Indigenous groups like the Munda and Dalits, landless farmers and fisherfolk, low-income households, climate migrants, and persons with disability. This research aims to interview eight (8) participants from each group which will result a total of forty-eight (48) participants.

### **5 Do I have to take part in this research project?**

Participation in any research project is voluntary. If you do not wish to take part, you do not have to. If you decide to take part and later change your mind, you are free to withdraw from the project at any stage.

If you do decide to take part, you will be given this Participant Information and Consent Form to sign and you will be given a copy to keep.

Your decision whether to take part or not to take part, or to take part and then withdraw, will not affect your relationship with the researchers or with RMIT University.

### **6 What are the possible benefits of taking part?**

We cannot guarantee or promise that you will receive any benefits from this research; however, you may appreciate contributing to knowledge generation and policy influence. Possible benefits may include increased awareness and a sense of empowerment regarding climate change and adaptation strategies, as well as the validation of the traditional knowledge and coping mechanisms of the residents. Although the study itself may not provide direct assistance, its findings could pave the way for future interventions that may lead to improved funding and policies for the vulnerable groups in South-west coastal Bangladesh.

**7 What are the risks and disadvantages of taking part?**

Participants may face some psychological and emotional risks when discussing distressing topics like climate-induced displacement, environmental degradation and loss of their livelihoods. You may feel that some of the questions we ask are stressful or upsetting. If you do not wish to answer a question, you may skip it and go to the next question, or you may stop immediately. If you become upset or distressed because of your participation in the research project, members of the research team will be able to discuss appropriate support for you. **8 What if I withdraw from this research project?**

If you do consent to participate, you may withdraw at any time. If you decide to withdraw from the project, please notify a member of the research team. You have the right to have any unprocessed data withdrawn and destroyed, providing it can be reliably identified.

**9 What happens when the research project ends?**

The research results will be discussed in the thesis as well as peer-reviewed academic publications after its completion in December 2027. Also, a summary of the results will be available upon request by contacting the student investigator at s4062475@student.rmit.edu.au after approximately December 2027.

**How is the research project being conducted?****10 What will happen to information about me?**

By signing the consent form, you consent to the research team collecting and using information from you for the research project. Any information obtained in connection with this research project that can identify you will remain confidential. Information collected during interviews will be treated as confidential and be used for research purposes only. Access to data/information will be restricted to the principal investigation team only. Only the people in the table are authorized to access and use the data to ensure confidentiality and protect data, and any personal or sensitive information will be removed and or disguised for all forms of publication. Data collection will involve anonymization, using codes instead of names and generalising identifiable details.

In any publication and/or presentation, information will be provided in such a way that you cannot be identified, except with your express permission. If we use any specific quotes or report any specific events, even if disguised, we will seek your permission to do so before we publish anything publicly. This does not apply to the thesis; however, this thesis will only be available to the researchers and the thesis examiners.

In accordance with relevant Australian and/or Victorian privacy and other relevant laws, you have the right to request access to the information about you that is collected and stored by the research team. You also have the right to request that any information with which you disagree be corrected. Please inform the research team member named at the end of this document if you would like to access your information.

Any information that you provide can be disclosed only if (1) it is protect you or others from harm, (2) if specifically allowed by law, (3) you provide the researchers with written permission. Any

information obtained for the purpose of this research project that can identify you will be treated as confidential and securely stored.

This research uses interviews to collect the data. The student investigator will opt for audio recording for your interview utilising a smartphone. Additionally, a local assistant will be involved for note taking using the printed questionnaire. Your interview will be translated and transcribed in English. Once transcribed, you will be given an opportunity to review your responses and edit as appropriate. You will be contacted via email and will be given two weeks to act and change your response. If you have no internet access and/or no email accounts, your response could be sent electronically to a trusted person you nominate (i.e. family member, friend) who owns an email account. This action will be done once you confirm this action with student investigator (over phone).

If you have no internet access, and no email access, and cannot nominate a trusted person of your trust with an email account, your response will be sent to you through the NGO representative. If you can't read, the NGO representative will explain the written response. If you wish to change your response, please contact the student investigator or the local NGO representative. You will have two weeks to comment or provide your feedback on your responses. Once the data are verified from you, the physical records and audio records will be destroyed. Translated data will be stored in RMIT University's private storage facilities the cloud storage (OneDrive), with access limited to the principal investigation team and will be destroyed after 5 years.

#### **11 Who is organising and funding the research?**

This research project is being conducted by Md. Riad Hossain and supervised by Dr. Nick Brown (Senior Supervisor), Dr. Spyros Schismenos (Associate Supervisor), and Prof. Dr. Darryn McEvoy (Associate Supervisor). The project is funded by RMIT internal HDR funding.

#### **12 Who has reviewed the research project?**

All research in Australia involving humans is reviewed by an independent Ethics review body. This research project has been approved by one of the RMIT University review bodies. This project will be carried out according to the *National Statement on Ethical Conduct in Human Research* (2023). This statement has been developed to protect the interests of people who agree to participate in human research studies.
