INTERVIEW GUIDE, FOCUS GROUP INTERVIEW	
<p>Briefing: The interview begins with introductions of the participants, then a brief introduction of the purpose of the focus group and some light small talk to establish trust. This is followed by a conversation about the participant's daily experiences with the issue under investigation – specifically the use of acute virtual consultations to support clinical decision-making for patients who have undergone plastic or breast surgery.</p>

Theme: Utopia (Based on the interviewer's preconceptions regarding the development of competencies for clinical decision-making in acute virtual consultations)	<p>Please provide suggestions regarding what you believe is needed in order for acute virtual consultations to become meaningful in clinical practice.</p> <p>Please share what you think is required to develop the necessary competencies for making clinical decisions in the context of acute virtual consultations.</p> <p>Please complete the following sentences:</p> <p>In this way... we would truly be strengthening our competencies for clinical decision-making in acute virtual consultations.</p> <p>It would be ideal if...</p> <p>It would be meaningful if...</p> <p>Would you be willing to elaborate on that?
