Data collection	X-ray diffraction data were collected at Diamond Synchrotron (UK) on beamline I03 (0.9762 Å) at 93 K. S-SAD experiments were carried out on on beamline I23 (Diamond Synchrotron) at 4.5 keV (2.755 Å).
Data analysis	Data were processed using XDS. bGLYAT models were generated ab initio with RosettaFold and used for molecular replacement (MR) using PHASER. Refinement and model building were performed in Refmac and COOT. S-SAD data was processed using XDS through xia2. Datasets were merged using XSCALE. SHELXD and CRANK2 were used for structure solution and initial model building. Figures were prepared using PyMOL.
