Data collection

No custom data-collection software was used to acquire new observations. The study uses public astronomical datasets and simulations: Galaxy DECaLS from the DESI Legacy Imaging Surveys with Galaxy Zoo labels, SDSS Data Release 17 spectra and the PLAsTiCC survey.

Data analysis

Data analysis used custom ATLAS benchmark code together with PyTorch 2.1, scikit-learn methods where applicable, Astropy and Ubuntu 22.04 LTS. Neural training used AdamW, cosine annealing and fixed random seed 42 on NVIDIA A100 GPUs. Figure-reproducibility metadata in the project records Python 3.12.3, matplotlib 3.10.5, seaborn 0.13.2, numpy 2.3.2, pandas 2.3.2, h5py 3.14.0 and torch 2.8.0+cu128 for the frozen figure-generation package.
